1. Lift Station Repair: Mike Gerardy, Administrative Coordinator and Tony Klug, Water/Waste Water Supervisor, will present information on estimates for repair of 2 lift stations. The first lift station known to need service is the industrial park lift station adjacent to Bissen Street. The following estimates have been received with regard to repairing that lift station. North Star Pump Service: \$26,469. Braun Pump and Controls: \$23,997. Addendums #3 & #4

The second lift station is the East Side Lift Station located at the east end of Bush Street in the South Winnebago Estates Addition. The estimated cost for repair of that lift station may be approximately the same as for the one above.

Police Officer Position: The Council Committee (Vick and Klug) meet with Chad Heuser to discuss final arrangements before making a recommendation to the City Council on whether or not the job offer should be made in its final form.
