- B. Criminal Justice Center: Does the Council have any open meeting action or motions to make regarding the results of the above Closed Session?

- C. Congratulatory Sign: A number of clubs and individuals wish to honor the Warrior Football Team for winning the State Championship the past two years. They wish to do this by erecting a sign, perhaps in the North Park, provided permission can be obtained from the City Council. All expenses of the sign and installation would be paid by the above parties. If the Council grants permission, the details as to the exact location, size of the sign, and the like can be worked out with a council committee.

Liquor Regulations: Elsie Vesterse, Elsie's Bar & Restaurant, has expressed an interest in staying open until 2:00 a.m. In order to do this, Elsie would have to obtain an application form from the State of Minnesota and, depending upon her gross sales, pay a prescribed fee to the State of Minnesota. The application form has a signature block for the City Council to sign off, indicating they have no objection to the 2:00 a.m. closing time. If the Council objects to this 2:00 a.m. closing, it must draft an ordinance establishing the times that the Council would allow sales of alcoholic beverages in the City. See Minnesota Statute 340A.504, Subd. 6 & Subd. 7. Addendum #3

 - 1. Budget Review: Stephanie Mann, City Accountant, will be present to review the adopted budget with the Council. In preparation for any Local Government Aid reductions to be made by the State in calendar year 2009, the Mayor has directed that consideration to possible areas of cutbacks will be reviewed. Other than general conversation and naming of programs or departments at this meeting for consideration for cost reductions, perhaps the Council wishes to have a Committee designated to study the budget and report back with recommendations at the meeting of January 26. At this time, the governor has not indicated what

Local Government Aid cuts he will propose. The first indication of his plan will be revealed on January 27 when he gives his State of the State Address. Addendum #4
