- A. Zoning Application – Paulette Lawson: I recommend the Council deny the proposal made by Norman Snodgrass at the July 9 Council Meeting when he proposed building a two story home with two garages in front of the mobile home that sets on the property at 825 North Kingston Street. Houston County CJC: Since the Public Hearing on July 11, there have been continued committee meetings between Houston County representatives and City representatives regarding the CJC Center, its location and issues surrounding the zoning application procedure. While it appears necessary to re-advertise for a Public Hearing to consider revised plans for placement of the building along the east side of the property, adjacent to Pine Street and install parking lots throughout the entire Courthouse Square parcel. There would also be a new advertisement for vacating the two street segments. Among the issues discussed, however, was that the city would agree to accept the advertisement for parking stall number and dimensions based upon the original advertisement and would not obligate the county to re-advertise those at a new public hearing.
